### Household Income & Expenditure Survey 2016

In addition to this, information of household food consumption and consumed outside home over the past 7 days will be collected.

The disclosure of any individual or household information for legal or any other purpose is strictly prohibited, under regulation no: 2013/R-4 "Statistical Regulation of the Republic of Maldives". The information obtained from this survey will not be disclosed in any manner that will reveal the identity of an individual or household.

A designated team from the National Bureau of Statistics will visit your household to fill the survey questionnaires. We hope to get your full co-operation in providing the required information, as accurately as possible. Survey teams will have identification cards provided by the Bureau.
