Figure 8.41: Number of person sentenced by type, 2014 - 2016

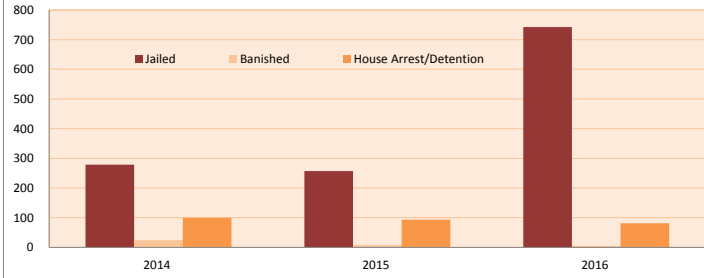


Figure 8.42: Number of person sentenced by period, 2014 - 2016
