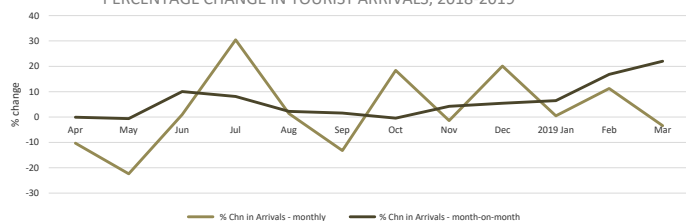

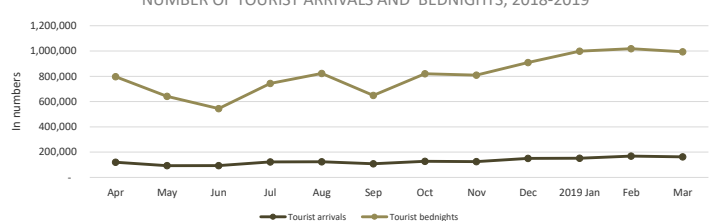

PERCENTAGE CHANGE IN TOURIST ARRIVALS, 2018-2019



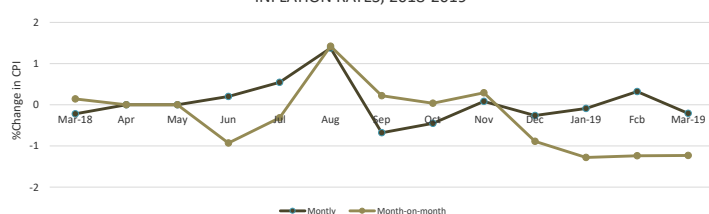
NUMBER OF TOURIST ARRIVALS AND BEDNIGHTS, 2018-2019

The Consumer Price Index for all groups declined by 0.21% in March 2019, compared to the rise of 0.32% in Feb 2019

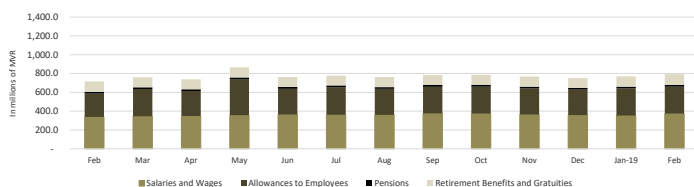
CPI Increased at the All Group Levels in Male' by 0.05% and in declined in Atolls by -0.45% in March 2019.

The Consumer Price Index for all groups fell by -1.23% through the year to March 2019, compared to the fall of -1.24% through the year to Feb 2019

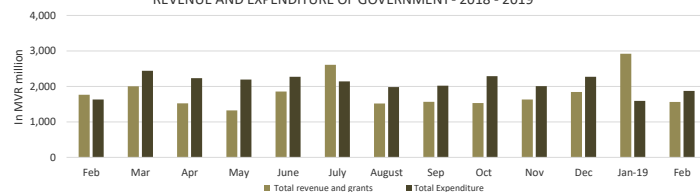

SALARIES , WAGES & PENSIONS, 2018 - 2019



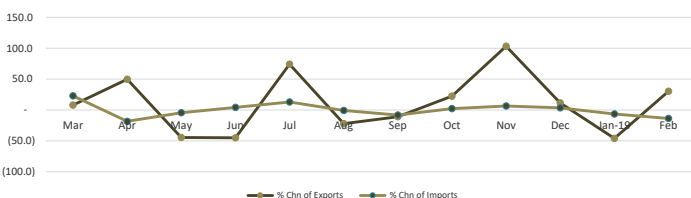
REVENUE AND EXPENDITURE OF GOVERNMENT - 2018 - 2019



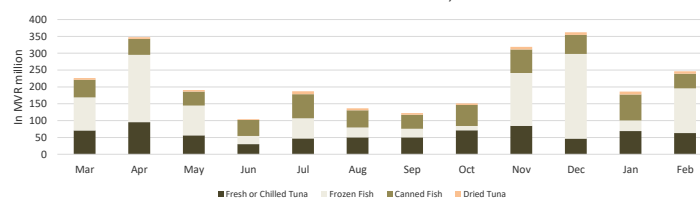

EXPORTS OF FISH PRODUCTS BY TYPE, 2018 - 2019



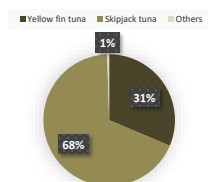
EXPORTS: The value of exports increased by 30.3 percent in February 2019 when compared to January 2019. The total value of exports in February 2019 is 264 million MVR (fob). Fish products accounting for major exports of Maldives increased by 31.8 percent in February 2019 compared to previous month.

IMPORTS: The value of imports decreased by 13.7 percent in February 2019 when compared to January 2019. The total value of imports in February 2019 is 3,314.4 million MVR (cif).

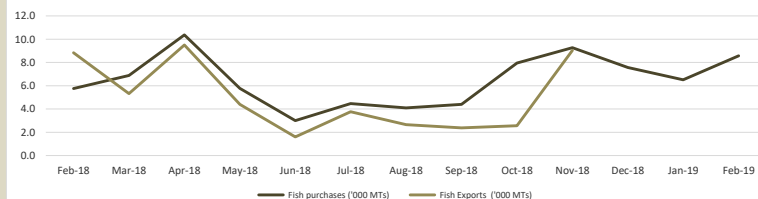

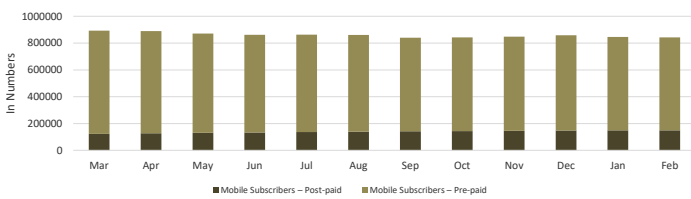

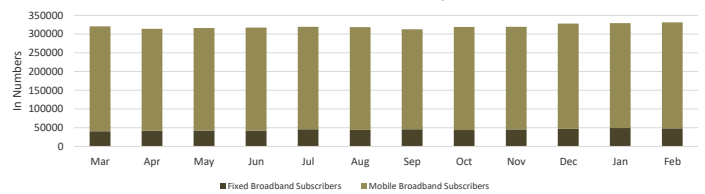

NUMBER OF MOBILE PHONE SUBSCRIBERS, 2018 - 2019



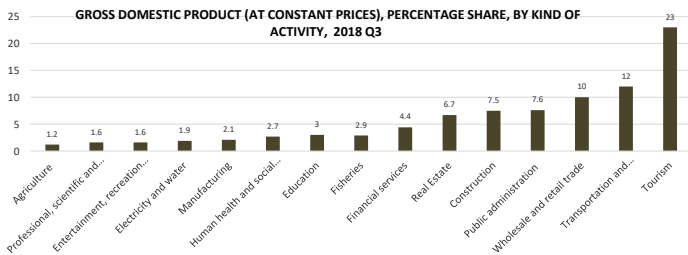
NUMBER OF INTERNET SUBSCRIBERS, 2018 - 2019



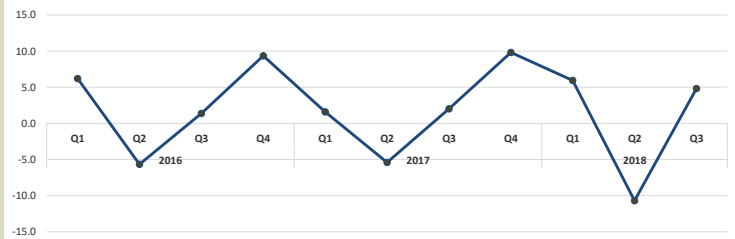
