Table 1 shows the nominal GDP at Market price from year 2016 to 2021 and total GVA at basic prices.

Nominal GDP at market price for year 2021 is MVR 83,098 million. This is an increase of 44.2 per cent in growth rate. Taxes less subsidies for year 2021 is MVR 10,422. This is an increase of MVR 5,003 million or an increase of 92.3 per cent compared to the previous year.

Figure 1 shows Nominal GDP per capita from year 2016 to 2021. GDP per capita for 2021 is US\$ 9,302. This is decline of 38.8 per cent in per capita growth rate compared to previous year. Average per capita growth rate for past five years is 3.03 per cent.

Figure 2: Percentage share of Nominal GDP 2021




Figure 2 shows the Nominal GDP percentage share for the year 2021.

Tourism sector has the largest percentage share of 21.4 per cent for 2021. Compared to previous year, tourism sector has increased its share by 9.8 percentage points in 2021. This is due to the recovery of tourism sector from the COVID-19 pandemic.

Transportation and communication the second largest with a percentage share of 9.5 per cent . Public administration sector with a percentage share of 8.4per cent was the third largest sector.

Water and sewage sector shares the lowest percentage in the Nominal GDP, with a share of 0.8 percent. Professional, scientific and technical activities has the second lowest share of 1.1 per cent for year 2021.

Table 2 shows the real GDP at Market price from year 2016 to 2021 and total GVA at basic prices.

Real GDP at market price for year 2021 is MVR 72,813 million. This is an increase of MVR 21,444 million compared to previous year, indicating a increment of 41.8 per cent in annual growth rate. Taxes less subsidies for year 2021 is MVR 6,986. This is an increase of MVR 4,123 million, which is an increase of – 91.3 per cent compared to previous year.

Figure 3: Real GDP, value and growth rate 2016-2021




Figure 3 shows the real GDP growth rate from 2016 to 2021.

As shown in the figure, over past years, real GDP shows positive growth rate except for year 2020. In 2020, Maldivian economy shrank by –33.5 per cent due to the impact of COVID-19 pandemic . However, in 2021, it expanded by 41.7 mainly fueled by the increase in tourism and transportation sector growth.

#### **IMPLICIT PRICE DEFLATOR**

Figure 4 shows the implicit price deflator (IPD) and growth rate of implicit price deflator.

IPD for the year 2021 is at 114. When compared to the previous year, 2021 shows a growth of 1.7 per cent depicting an increase in price level in overall economy.

The overall price level in 2019 declined mainly due to the decline in tourism sector prices.

# **TOURISM**




Figure 5 shows annual growth rate of Tourism sector from year 2016 to 2021.

Real GVA 2021 for tourism sector is MVR 18,786 million. This is an increment of 152.0 per cent in annual growth rate compared to previous year. This increase is due to the recovery of COVID-19 pandemic.




Figure 6 shows the number of tourist bed-nights and the growth rate. The number of tourist bed-nights increased by 5.9 million compared to year 2020, which is an increment of 149.1 percent. This huge increase in tourist bed-nights was due to the removal of travel restrictions of COVID-19 pandemic.

Figure 7: Public administration, growth rate 2016-2021





Figure 7 shows annual growth rate of Public administration sector from year 2016 to 2021.

Real GVA 2021 for public administration sector is MVR 6,642. Annual growth rate of public administration sector in 2021 is 0.2 per cent, depicting an increase in value added by public administration sector.

GVA for this sector is determined by government value added deflated by government wage index.

Figure 8: Transport & communication, Value and




Real GVA for transportation and communication sector is MVR 6,066 million. This is an increment of – 26 per cent compared to the previous year.

The sector had a huge impact due to the Covid-19 as mobility was restricted. Thus, in 2020 the sector contracted by 34.9 percent.

## WHOLESALE AND RETAIL TRADE

Figure 9: Wholesale and retail trade, Value and growth rate 2016 -2021




Real GVA for wholesale and retail trade sector is MVR 5,496.4 million. This is an increment of 41.7 per cent when compared to the previous year. This increase is due to recovery of COVID-19 pandemic. The COVID-19 pandemic has had a huge impact on the trade sector due to the restriction in transportation of goods due to the closure of borders.

Total percentage share for this sector is 8.2 per cent.

# **FINANCIAL SERVICES**

Figure 10: Financial services growth rate, 2016 -2021




Real GVA for Financial services sector is MVR 4,045 million. When compared to the previous year 2021, it shows a growth of 17 per cent depicting an increase in financial services.

This is due to increase of both banking and insurance services during 2021.

Total percentage share for this sector is 7.1 per cent.

Figure 11: Construction Value, growth rate and BM growth rate 2016-2021




Real GVA for Construction sector is MVR 3,268 million. This is a decline of –4.9 per cent compared to the previous year.

This decline is depicted by the increase in the price of building materials and also decreasing buildings approved for the construction in the year 2020.

Total percentage share for this sector is 6.8 per cent .

Figure 12: Fisheries, Value and growth rate 2016-2021




Real GVA for fisheries sector is MVR 2,527 million as shown in Figure 12.
